City Ordinances Chapter 69.12

NO PARKING ALLOWED FOR SNOW REMOVAL NOVEMBER 1-APRIL 1

Per City Ordinance 69.12 - No person shall park, abandon or leave unattended any vehicle on any public street, alley, or City-owned off-street parking area during the period of time from November 1 to April 1 between the hours of 2:00 AM and 5:00 AM. Parking citations can be issued.

City Ordinances



Chapter 136.03 Removal of snow, ice, and accumulation

The abutting property owner shall remove snow, ice, and accumulations within a reasonable time, the City may do so and assess the costs against the property owner for collection in the same manner as a property tax. The abutting property owner may be liable for damages caused by failure to remove snow, ice and accumulations promptly from the sidewalk.

Penalty—The city or their agents may remove snow, ice and accumulations, which are not removed within 48 hours. A charge of \$50 per man/per hour plus a surcharge of \$75 will be charged to the property owner for such removal—which provided no payment shall be assessed in the same manner as general property taxes.

FYI!

Recently, the city has had an adjustment made to the stoplight at the intersection of Main and Maple streets. We had a fish eye camera installed. This change will result in the stoplight from the north and south to always be green unless there is a car waiting on Maple Street. We are hoping this improvement will help with the truck noise on main street and help prevent people from speeding up to beat the light!

Ash Tree Removal Customer Compensation

The ash bore beetle has moved into our community and is killing ash trees. This has resulted in many trees that need to be removed which has generated an extensive tree removal list for the city's professional tree removal company.

Per council 9-5-23, a compensation of \$100 per tree for dead, diseased, or dangerous ash trees on city right of way only was approved for property owners who wish to remove said ash trees from the right of way on their property at the property owner's own expense without waiting for the city to remove the tree(s).

Ordinance chapter 151.10 All stump removal and clean-up are the responsibility of the abutting property owner.

If a property owner chooses to remove their dead, diseased, or dangerous ash tree(s) located in the city right of way prior to the city removing the tree(s) and wants the compensation payment, please contact city hall to request a tree removal permit application. There is no fee for the permit. This permit must be completed and approved **PRIOR TO REMOVAL** to receive the \$100 compensation.
