A motion was made by Council Member Stevenson and seconded by Council Member Wiese approving the consent agenda including Agenda, Minutes of the July 9, 2024, Regular Council Meeting, and claims. The Motion was duly put to a vote of the City Council. Ayes: Prell, Voss, Schimmer, Wiese, and Stevenson. Nays: none. Motion carried. Ordinance 259 Amending the Code of Ordinances of the City of Holstein, Iowa, By Repealing Chapter 117 Pertaining to the Urban Forestry Utility Fee was offered by Council Member Schimmer and Seconded by Council Member Voss. The first Reading of Ordinance 259 passed, and 2nd reading will be at the next regular council meeting August 13th, 2024. Ordinance 260 Amending the Code of Ordinances of the City of Holstein, Iowa, By Amending provisions Pertaining to Water Rates was offered by Council Member Wiese and seconded by Council Member Prell.
